

LICENSEE SHOULD CAREFULLY READ THE FOLLOWING TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT BEFORE INSTALLING THIS PACKAGE. IF LICENSEE DOES NOT AGREE WITH THESE TERMS AND CONDITIONS, PLEASE PROMPTLY RETURN THIS SOFTWARE FOR A FULL REFUND.

SPECTRUM CORPORATION (hereafter "Spectrum") hereby grants Licensee a non-exclusive, nontransferable license to use Vectra-View for Windows (the "Software") and the accompanying documentation according to the following terms:

1. LICENSE GRANT: Licensee may 1) install and use the Software on only one computer at a time, and 2) make one (1) copy of the Software in machine readable form solely for backup purposes.

2. LICENSE RESTRICTIONS: Licensee may not: 1) transmit the Software over a network without an additional license; 2) modify, adapt, translate, reverse engineer, decompile, disassemble, create derivative works based on, or copy (except for backup copy) the Software or the accompanying documentation without the prior, express written consent of Spectrum or 4) remove any proprietary notices, labels or marks on the Software and accompanying documentation.

3. NATURE OF THIS AGREEMENT: The Software is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. This license is not a sale. Title and copyrights to the Software, accompanying documentation, and any copy made by Licensee, remain the property of Spectrum. Unauthorized copying of the Software or the accompanying documentation, or failure to comply with the above restrictions is a material breach of this Agreement and shall automatically terminate this license, without further notice, and terminate Licensee rights to use the Software. In the event of such termination, Spectrum shall, in addition to its other legal remedies, be entitled to its reasonable attorney fees.

4. LIMITED WARRANTY: Spectrum warrants that, for a period of ninety (90) days from the date of delivery to Licensee the Software, as furnished, under normal use, will perform substantially in accordance with its documentation. Spectrum's entire liability and Licensee's exclusive remedy under this warranty will be, at the option of Spectrum, to correct errors, to replace the Software with functionally equivalent Software, or to refund the license fee of the Software and terminate this agreement. In the event of termination, Licensee will return the Software to Spectrum before refund will be executed.

EXCEPT FOR THE ABOVE EXPRESS LIMITED WARRANTY, SPECTRUM DISCLAIMS ALL OTHER WARRANTIES, EXPRESS, IMPLIED, STATUTORY, OR IN ANY COMMUNICATION WITH LICENSEE, AND SPECTRUM SPECIFICALLY DISCLAIMS ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. SPECTRUM DOES NOT WARRANT THAT THE OPERATION OF THE SOFTWARE WILL BE UNINTERRUPTED OR ERROR FREE.

Some states do not allow the exclusion of implied warranties so the above exclusions may not apply to Licensee. This warranty gives Licensee specific legal rights. The Licensee many also have other rights which vary from state to state.





5. LIMITATION OF LIABILITY: EXCEPT FOR GROSS NEGLIGENCE OR WILLFUL MISCONDUCT OF SPECTRUM OR LICENSEE, THEIR AGENTS AND EMPLOYEES, OR WITH RESPECT TO BOTH PARTIES' OBLIGATIONS FOR INDEMNIFICATION CONTAINED IN SECTION 6 OF THIS AGREEMENT, IN NO EVENT WILL EITHTER PARTY BE LIABLE FOR ANY DAMAGES, INCLUDING LOSS OF DATA, WHEN LOADING THIS SOFTWARE OR OTHERWISE, OR LOST PROFITS, COST OF COVER OR OTHER SPECIAL, INCIDENTAL, CONSEQUENTIAL, OR INDIRECT DAMAGES ARISING FROM THE USE OF THE SOFTWARE OR ACCOMPANYING DOCUMENTATION, HOWEVER CAUSED AND ON ANY THEORY OF LIABILITY. THIS LIMITATION WILL APPLY EVEN IF SPECTRUM HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE. LICENSEE ACKNOWLEDGES THAT THE LICENSE FEE REFLECTS THIS ALLOCATION OF RISK.

Some states do not allow the limitation or exclusion of liability for incidental, or consequential damages so the above limitation may not apply to the Licensee.

6. INDEMNIFICATION: Spectrum agrees to defend, indemnify, and hold Licensee harmless from all loss, cost, liability, and expense (including reasonable attorney's fees) incurred as the result of a claim that the Software infringes upon or violates the copyright, patent, trade secret or other intellectual property right of a third party. Should Licensee be enjoined, or in Spectrum's reasonable judgment likely to be enjoined, from using the Software, Spectrum at its option and expenses shall (i) obtain for Licensee the continuing right to use the Software or (ii) modify or replace the Software with non-infringing Software which provides comparable functionality and performance. If neither of the foregoing can be accomplished on commercially reasonable terms Spectrum shall refund to Licensee the license fee paid for the Software, plus all paid but unearned maintenance fees, and upon receipt of such refund Licensee shall return the Software to Spectrum and this Agreement shall terminate.

7. GENERAL: This agreement shall be governed by, and interpreted under, the laws of the State of Texas. This agreement is the entire agreement between parties and supersedes any other communications or advertising with respect to the Software and accompanying documentation. Neither party may assign this Agreement without the prior written consent of the other party. If any provision of this agreement is held invalid, the remainder of this Agreement shall continue in full force and effect.
