LICENSE AGREEMENT TO USE ONE COPY OF THE MONET SOFTWARE

THIS AGREEMENT APPLIES TO THE MONET SOFTWARE'S COMPUTER PROGRAM ("SOFTWARE") WITH WHICH THIS SOFTWARE LICENSE AGREEMENT IS INCLUDED AND ANY ASSOCIATED UPDATES, MAINTENANCE RELEASES, MEDIA, DATA, PRINTED MATERIALS, AND ONLINE OR ELECTRONIC DOCUMENTATION. IT APPLIES TO ALL VERSIONS OF THE SOFTWARE INCLUDING, TRIAL, SINGLE-USER, MULTIPLE-USER, EDUCATIONAL, ORIGINAL EQUIPMENT MANUFACTURER ("OEM"), SPECIAL EDITION, ONLINE AND ANY OTHER VERSION. ANY OTHER SOFTWARE PRODUCT PROVIDED TO YOU BY MONET SOFTWARE, OR AN AFFILIATE, UNDER A SEPARATE LICENSE AGREEMENT IS LICENSED TO YOU UNDER THE TERMS OF THAT LICENSE AGREEMENT.

1) LIMITED GRANT OF LICENSE

In consideration of your payment of any license fees and your agreement to abide by the terms and conditions of this Agreement, Monet Software grants you a non-exclusive, non-transferable, object code license ("License") to install, use, access, display, run and otherwise interact with ("Run") one copy of the Software and associated materials on a single computer or workstation ("Computer"). You may not copy the printed materials accompanying the Software if any, or print multiple copies of any user documentation.

You may store or install a copy of the Software on a network server, or similar device, to run the Software on your other Computers that are inter-connected by an internal network; however, you must acquire and dedicate a license for each separate Computer on which the Software is Run from the storage device. You may not use a single license to share the Software, or use it concurrently, on different Computers.

If you acquired the accompanying Software under a Monet Software Corporate License then you may install and Run additional copies of the Software up to the number specified above. You may also make one (1) copy of the Software for portable computer use, or for backup purposes, for each copy of the Software that you are licensed to install and Run.

2) SCOPE OF SOFTWARE LICENSE

You, or the primary user of the computer, on which the Software is installed ("You" or "licensee"), may keep the original media on which the Software was supplied by Monet Software or, if that original media is

used to run the Software, may make one (1) copy of the Software, in machine-readable form, for use on a portable computer or for nonproductive back-up purposes only. If you make a copy of the Software for non-productive back-up purposes, you must label that copy of the Software with the copyright, trademark, and proprietary notices in the same form that appears on the Software delivered to you.

The Software may be used only in accordance with the License granted under this Agreement. You may not rent, lease, transfer, network, display, or distribute the Software except as expressly provided herein, nor may you modify, alter, translate, or adapt the Software, or any copy, adaptation, transcription, or merged portion thereof, or create any derivative thereof.

Rights granted under the License may not be transferred except to (i) a successor in interest of your entire business who assumes the obligations of this Agreement; or (ii) any other party who is reasonably acceptable to Monet Software, and who enters into a substitute version of this Agreement, and pays an administrative fee intended to cover attendant costs. No service bureau work or time-sharing arrangement is permitted.

The Software is designed for use with accessories and other third party offerings. Monet Software assumes no responsibility under this Agreement for delivering or endorsing such accessories. You are responsible for ensuring a proper environment and proper utilities for the Computer System on which the Software operates, including an uninterrupted power supply.

If you, copy, or modify the Software or if you transfer possession of any copy, adaptation, transcription, or merged portion of the Software to any other party in any way without the prior written consent of Monet Software, the License shall be terminated in accordance with the terms contained in Section 6 of this Agreement.

You may receive the Software in more than one medium; however, you may only use one medium to install and Run the Software on your single computer. You may not use the other media to install and run the Software on other computers, notwithstanding the other terms and conditions in this Agreement.

3) RESERVATION OF TITLE

- a) You agree that nothing herein shall give you any right, title, or interest in the Software, or any modifications and enhancements thereto, (except the right to use the Software in accordance with the terms of this Agreement), and that the Software, and any modifications and enhancements thereto, are the sole and exclusive property of Monet Software including any trade secret, copyright and patent rights.
- b) You further acknowledge that the Software is proprietary to Monet Software, and you agree to take no action or position inconsistent with Monet Software's proprietary rights. You further agree not to disclose any of Monet Software's trade secrets by disassembling, decompiling, or otherwise reverse-engineering the Software.
- c) The Software is a commercially valuable, proprietary product of Monet Software, the design and development of which reflect the effort of skilled development experts and the investment of considerable time and money. The Software is treated by Monet Software as confidential and contains substantial trade secrets of Monet Software, which Monet Software has entrusted to you in confidence to use only as expressly authorized. Monet Software claims and reserves all rights and benefits afforded under federal copyright law in all software programs and user materials that constitute the Software, and in all documentation related thereto, as unpublished works.
- d) You may not, at any time, disclose or disseminate the Software to any person who does not need to obtain access thereto consistent with your rights under this Agreement. Under no circumstances may you "unlock" the code of the Software, as the term is generally used in the trade. Under no circumstances may you disclose or disseminate the Software to any competitor of Monet Software. You will devote your best efforts to ensure that all other persons afforded access to the Software, such as your personnel, shall protect it against improper use, dissemination or disclosure. You shall not create, attempt to create, or permit anyone to create, by reverse engineering, computer programming, or otherwise, any part of the programs or the data files stored within the Software, or from any other information made available to you, whether oral, written, tangible or intangible.
- e) Your obligations hereunder shall remain in effect for as long as you continue to possess or use the Software or any trade secrets derived there from.
- 4) LIMITED WARRANTY AND DISCLAIMER OF WARRANTY

- b) Monet Software warrants that it has the right to grant the License and that the Software will perform substantially in accordance with the Software specifications contained in the user manual for a period of ninety (90) days from the date you receive the Software. This warranty is expressly conditioned on your observance of the operating, security, and data-control procedures set forth in the Software user manual. Monet Software, however, is not responsible for obsolescence of the Software that may result from changes in your requirements. However, Monet Software shall not be obligated to correct, cure, or otherwise remedy any nonconformity or defect in the Software if you made any changes whatsoever to the Software, if the Software has been misused or damaged in any respect, or if you have not reported to Monet Software the existence and nature of such nonconformity or defect promptly upon discovery thereof.
- d) To the extent contractually allowed, Monet Software assigns to you all right and benefit, if any, now or hereafter held by Monet Software under warranties made or furnished by the manufacturers or suppliers of all third party software procured by Monet Software prior to resale to you.
- e) Monet Software does not warrant that the function contained in the Software will meet your specific requirements or that the operation of the Software will be uninterrupted or error free. The Software warranty provided above in Sections 4(b)-(c) does not extend to Software that has been altered or changed in any way without the prior written consent of Monet Software. Monet Software is not responsible for the problems caused by changes in the operating characteristics of the Computer System which are made after delivery of the Software unless they were made or authorized by Monet Software; nor is Monet Software responsible for problems that occur as a result of the use of the Software in conjunction with software not provided by Monet Software.
- f) EXCEPT AS EXPRESSLY SET FORTH IN THIS AGREEMENT, MONET SOFTWARE DISCLAIMS ANY AND ALL PROMISES, REPRESENTATIONS, AND WARRANTIES WITH RESPECT TO THE SOFTWARE, INCLUDING ITS CONDITIONS, ITS CONFORMITY TO ANY REPRESENTATION OR DESCRIPTION, THE EXISTENCE OF ANY LATENT OR PATENT DEFECTS, AND ITS MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

5) LIMITATION OF LIABILITY

IN NO EVENT SHALL MONET SOFTWARE OR ITS SUBSIDIARIES, AGENTS, AFFILIATES, LICENSORS, THIRD-PARTY CONTENT OR SERVICE PROVIDERS, PARTNERS, DISTRIBUTORS, DEALERS OR SUPPLIERS ("REPRESENTATIVES"), BE LIABLE TO YOU UNDER THIS AGREEMENT FOR ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, INCLUDING, BUT NOT LIMITED TO, LOSS OF PROFITS OR BUSINESS INTERRUPTION, DATA OR USE, BASED UPON PRINCIPLES OF CONTRACT, WARRANTY, NEGLIGENCE, STRICT LIABILITY OR OTHER TORT, BREACH OF ANY STATUTORY DUTY, PRINCIPLES OF INDEMNITY OR CONTRIBUTION, IN CONNECTION WITH THIS AGREEMENT, EVEN IF MONET SOFTWARE OR ITS REPRESENTATIVES HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. NOTWITHSTANDING THE FOREGOING, IN NO EVENT WILL MONET SOFTWARE OR ITS REPRESENTATIVES' CUMULATIVE LIABILITY UNDER THIS AGREEMENT EXCEED THE AMOUNT THAT YOU PAID FOR THE SOFTWARE UNDER THIS AGREEMENT AS OF THE DATE THE CAUSE OF ACTION ARISES. 6) TERM AND TERMINATION

- a) The License granted to you hereunder, shall become effective upon acceptance of this Agreement and shall continue in perpetuity unless terminated as provided herein.
- b) The License granted under this Agreement may be terminated immediately by Monet Software if: (i) you breach any of the material terms of this Agreement; or (ii) you make an assignment for the benefit of your creditors, or a receiver or trustee in bankruptcy (or the equivalent) shall be appointed for you.

- c) In the event of termination of the License or upon discontinuance or abandonment of your possession or use of the Software, you shall discontinue immediately your use of the Software and shall return, or certify the destruction of, all copies of the Software in your possession (whether modified or unmodified), and all other materials pertaining to the Software (including all copies thereof).
- d) Upon termination of this Agreement for any reason, the License granted to you will immediately terminate, and the provisions of Section 6(c) shall apply.

7) FORCE MAJEURE

Monet Software shall not be responsible for failure to fulfill, or delay in fulfilling its obligations under this Agreement due to causes beyond Monet Software's control.

8) INJUNCTION RELIEF

You agree that a violation of this Agreement would cause irreparable injury to Monet Software, and that Monet Software is entitled to, in addition to any other rights and remedies it may have, at law or in equity, to an injunction enjoining and restraining you from doing or continuing to do such an act and any other violations or threatened violations of this Agreement. Furthermore, you agree that if Monet Software should waive any breach of any provision of this Agreement, it shall not thereby be deemed to have waived any preceding or succeeding breach of the same of any other provision of this Agreement.

9) MISCELLANEOUS

- a) You expressly agree that the terms of this Agreement shall supersede the terms contained in any other purchase order or other ordering document related to the Software.
- b) You must not assign this Agreement to a third party without the prior written consent of Monet Software, such consent not being unreasonably withheld.
- c) No modification of this Agreement shall be binding unless it is in writing and is signed by authorized representatives of both parties.
- d) Any notices required or permitted under this Agreement shall be in writing and delivered in person or sent by registered or certified mail, return receipt requested, with proper postage affixed, addressed as follows:

- e) In the event that any term of this Agreement is or becomes or is declared to be invalid or void by any court or tribunal of competent jurisdiction, such term or terms shall be null and void and shall be deemed severed from this Agreement, and all the remaining terms of this Agreement shall remain in full force and effect.
- f) This Agreement shall be governed and construed in accordance with the laws of the state of California. Jurisdiction over any dispute relating to or arising out of this Agreement will be exclusively in Los Angeles County, California.
- g) The waiver by either party of a breach of any provision of the terms and conditions of this Agreement, or to exercise any right or privilege hereunder, shall not be construed as a waiver of such terms, conditions, right or privilege in the future.
- h) You warrant that you are free, as of the date you accept this Agreement, of any contractual obligation that would prevent you from entering into this Agreement. You further represent and warrant that the party executing this Agreement is duly authorized to do so and you waive any defense you have, or in the future may have, with respect to the valid and binding execution of this Agreement by an authorized representative.
- i) The headings inserted in this Agreement are for convenience only and shall not affect the meaning or interpretation of this Agreement.
- j) This Agreement shall be the only Agreement between you and Monet Software with respect to the License of the Software. This Agreement supersedes all prior representations and/or agreements, written

or oral, relating to the License of the Software.

- k) The terms of Section 3 shall survive any termination of this Agreement.
- I) You understand that in supplying this Software to you, Monet Software is not engaged in rendering legal, accounting or other professional service. If legal advice or other expert assistance is required, the service of a competent professional person should be sought.
- m) U.S. Government: The Software is a "commercial item," as that term is defined at 48 C.F.R. 2.101 (OCT 1995), consisting of "commercial computer software" and "commercial computer software documentation," as such terms are used in 48 C.F.R. 12.212 (SEPT 1995) and the Department of Defense Federal Acquisition Regulations Sections 252.227-7014 (a) (1), (5).
