



TELSTRAT INTERNATIONAL LTD
End User License Agreement

BY DOWNLOADING OR INSTALLING THE SOFTWARE, OR USING THE EQUIPMENT THAT CONTAINS THIS SOFTWARE, YOU ARE CONSENTING TO BE BOUND BY THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, THEN (A) DO NOT DOWNLOAD, INSTALL OR USE THE SOFTWARE, AND (B) YOU MAY RETURN THE SOFTWARE FOR A FULL REFUND, OR, IF THE SOFTWARE IS SUPPLIED AS PART OF ANOTHER PRODUCT, YOU MAY RETURN THE ENTIRE PRODUCT FOR A FULL REFUND. YOUR RIGHT TO RETURN AND REFUND EXPIRES 30 DAYS AFTER PURCHASE FROM TELSTRAT OR AN AUTHORIZED TELSTRAT RESELLER, AND APPLIES ONLY IF YOU ARE THE ORIGINAL PURCHASER.

License

Subject to the terms and conditions of and except as otherwise provided in this Agreement, TelStrat International, Ltd., ("TelStrat") and its suppliers grant to Customer ("Customer") a nonexclusive and nontransferable license to use the specific TelStrat program modules (TelStrat Application Line Card [TALC] embedded Software, TALC management application Software, Engage Record server software and Engage Record client software), ActiveX CTI API, feature set(s) or feature(s) for which Customer has paid the required license fees (the "Software"), in object code form only. In addition, the foregoing license shall also be subject to each of the following limitations:

- (i) Unless otherwise expressly provided in the documentation, Customer shall use the Software solely as embedded in, for execution on, or where the applicable documentation permits installation on non-TelStrat equipment for communication with TelStrat equipment owned or leased by Customer;
- (ii) Customer's use of the TelStrat Application Line Card (TALC) embedded Software shall be limited to use on a single TALC, or use on such greater number of TALC units as Customer may have paid TelStrat the required channel license fee; and
- (iii) Customers may install the TALC management application Software on an unlimited number of computers for the purpose of managing TALC units that contain TALC embedded Software; and
- (iv) Customers may install the Engage Record server software on a single computer for the purpose of communicating with TALC units and Engage Record client software; and
- (v) Customers may install the Engage Record client software on an unlimited number of computers for the purpose of communicating with the Engage Record server software.

General Limitations

Except as otherwise expressly provided under this Agreement, Customer shall have no right and Customer specifically agrees not to:

- (i) transfer, assign or sublicense its license rights to any other person, or use the Software on unauthorized or secondhand TELSTRAT equipment, and any such attempted transfer, assignment or sublicense shall be void;
- (ii) make error corrections to or otherwise modify or adapt the Software or create derivative works based upon the Software, or to permit third parties to do the same; or
- (iii) de-compile, decrypt, reverse engineer, disassemble or otherwise reduce the Software to human-readable form to gain access to trade secrets or confidential information in the Software.

Upgrades and Additional Copies

For purposes of this Agreement, "Software" shall include (and the terms and conditions of this Agreement shall apply to) any upgrades, updates, bug fixes or modified versions (collectively, "Upgrades") or backup



copies of the Software licensed or provided to Customer by TelStrat or an authorized distributor for which Customer has paid the applicable license fees.

NOTWITHSTANDING ANY OTHER PROVISION OF THIS AGREEMENT: (1) CUSTOMER HAS NO LICENSE OR RIGHT TO USE ANY SUCH ADDITIONAL COPIES OR UPGRADES UNLESS CUSTOMER, AT THE TIME OF ACQUIRING SUCH COPY OR UPGRADE, ALREADY HOLDS A VALID LICENSE TO THE ORIGINAL SOFTWARE AND HAS PAID THE APPLICABLE FEE FOR THE UPGRADE; (2) USE OF UPGRADES IS LIMITED TO TELSTRAT EQUIPMENT FOR WHICH CUSTOMER IS THE ORIGINAL END USER PURCHASER OR LESSEE OR WHO OTHERWISE HOLDS A VALID LICENSE TO USE THE SOFTWARE WHICH IS BEING UPGRADED; AND (3) USE OF ADDITIONAL COPIES IS LIMITED TO BACKUP PURPOSES ONLY.

Proprietary Notices

Customer agrees to maintain and reproduce all copyright and other proprietary notices on all copies, in any form, of the Software in the same form and manner that such copyright and other proprietary notices are included on the Software. Except as expressly authorized in this Agreement, Customer shall not make any copies or duplicates of any Software without the prior written permission of TelStrat. Customer may make such backup copies of the Software as may be necessary for Customer's lawful use, provided Customer affixes to such copies all copyright, confidentiality, and proprietary notices that appear on the original.

Protection of Information

Customer agrees that aspects of the Software and associated documentation, including the specific design and structure of individual programs, constitute trade secrets and/or copyrighted material of TelStrat. Customer shall not disclose, provide, or otherwise make available such trade secrets or copyrighted material in any form to any third party without the prior written consent of TelStrat. Customer shall implement reasonable security measures to protect such trade secrets and copyrighted material. Title to Software and documentation shall remain solely with TelStrat.

Limited Warranty

If Customer obtained the Software directly from TelStrat, then TelStrat warrants that during the Warranty Period (as defined below): (i) the media on which the Software is furnished will be free of defects in materials and workmanship under normal use; and (ii) the Software will substantially conform to its published specifications. The "Warranty Period" means a period beginning on the date of Customer's receipt of the Software and ending on the later of (a) ninety (90) days from the date of initial shipment of the Software by TelStrat, or (b) the end of the minimum period required by the law of the applicable jurisdiction. The limited warranties extend only to Customer as the original licensee. Customer's sole and exclusive remedy and the entire liability of TelStrat and its suppliers under these limited warranties will be, at TelStrat or its service center's option, repair, replacement, or refund of the Software if reported (or, upon request, returned) to TelStrat or its designee. Except as expressly granted in this Agreement, the Software is provided AS IS. TelStrat does not warrant that the Software is error free or that Customer will be able to operate the Software without problems or interruptions.

This warranty does not apply if the Software (a) is licensed for beta, evaluation, testing or demonstration purposes for which TelStrat does not receive a license fee, (b) has been altered, except by TelStrat, (c) has not been installed, operated, repaired, or maintained in accordance with instructions supplied by TelStrat, or (d) has been subjected to abnormal physical or electrical stress, misuse, negligence, or accident.

If Customer obtained the Software from a TelStrat reseller, the terms of any warranty shall be as provided by such distributor, and TelStrat provides Customer no warranty with respect to such Software.



Disclaimer of Warranties

EXCEPT AS SPECIFIED IN THIS WARRANTY, ALL EXPRESS OR IMPLIED CONDITIONS, REPRESENTATIONS, AND WARRANTIES INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY OR CONDITION OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT, SATISFACTORY QUALITY OR ARISING FROM A COURSE OF DEALING, USAGE, OR TRADE PRACTICE, ARE HEREBY EXCLUDED TO THE EXTENT ALLOWED BY APPLICABLE LAW. TO THE EXTENT AN IMPLIED WARRANTY CANNOT BE EXCLUDED, SUCH WARRANTY IS LIMITED IN DURATION TO THE WARRANTY PERIOD. BECAUSE SOME COUNTRIES, STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, THE ABOVE LIMITATION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS, WHICH VARY FROM JURISDICTION TO JURISDICTION.

Disclaimer of Liabilities

IN NO EVENT WILL TELSTRAT OR ITS SUPPLIERS BE LIABLE FOR ANY LOST REVENUE, PROFIT, OR DATA, OR FOR SPECIAL, INDIRECT, CONSEQUENTIAL, INCIDENTAL, OR PUNITIVE DAMAGES HOWEVER CAUSED AND REGARDLESS OF THE THEORY OF LIABILITY ARISING OUT OF THE USE OF OR INABILITY TO USE THE SOFTWARE EVEN IF TELSTRAT OR ITS SUPPLIERS HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

In no event shall TelStrat or its suppliers' liability to Customer, whether in contract, tort (including negligence), or otherwise, exceed the price paid by Customer. The foregoing limitations shall apply even if the above-stated warranty fails of its essential purpose. BECAUSE SOME COUNTRIES, STATES OR JURISDICTIONS DO NOT ALLOW LIMITATION OR EXCLUSION OF CONSEQUENTIAL OR INCIDENTAL DAMAGES, THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

Term and Termination

This Agreement is effective until terminated. Customer may terminate this Agreement at any time by destroying or returning to TelStrat all copies of Software including any documentation. Customer's license rights under this Agreement will terminate immediately without notice from TelStrat if Customer fails to comply with any provision of this Agreement. Upon termination, Customer must destroy all copies of Software in its possession or control.

Export

Software, including technical data, may be subject to U.S. export control laws, including the U.S. Export Administration Act and its associated regulations, and may be subject to export or import regulations in other countries. Customer agrees to comply strictly with all such regulations and acknowledges that it has the responsibility to obtain licenses to export, re-export, or import Software.

General

This Agreement shall be governed by and construed in accordance with the laws of the State of Texas, United States of America, as if performed wholly within the state and without giving effect to the principles of conflict of law. If any portion hereof is found to be void or unenforceable, the remaining provisions of this Agreement shall remain in full force and effect. TelStrat hereby specifically disclaims the UN Convention on Contracts for the International Sale of Goods. Except as expressly provided herein, this Agreement constitutes the entire agreement between the parties with respect to the license of the Software and supersedes any conflicting or additional terms contained in the purchase order.
